P.R.O. 14646 (Permanent Representative Organization 14646) HEADQUARTERS as an International Supreme Treasury Organization is devoted to Global Peace and World Union with donations made into DONG MEN HUI (WORLD UNION), INTERNATIONAL MEI HUA ASSOCIATIONS, WORLD TAOISM ASSOCIATION, and other Charity Organizations.

The 20th Century (C20) P.R.O. 14646 Headquarters (HQ) Founder Members consisted of 17 prominent decision-makers led by:

1) **General LI XIAO PEI (Security Code: xxxx-3069)**

4) **YANG JIN CHEN (Security Code: xxxx-3067)**

- TRUSTEE AND HISTORICAL ASSET CONTROLLER -

General Li also popularly known as **IRON SOLE LI SAN PIAU / LI DAU PEI (HUA SEN / RED PLUM)** was acting as Chief Director of the CENTRAL SECURITY COUNCIL.

**Permanent Representation Organization 14646 (P.R.O.14646)**

**Organization Brief:**

P.R.O. 14646 (Permanent Representative Organization 14646) is an International Supreme Treasury Organization, devoted to Global Peace and World Union. P.R.O. 14646 is a major stake holder in the IMF, the World Bank, and other major financial organizations worldwide.

The origins of the resources of this organization arise from the donations made into DONG MEN HUI (WORLD UNION) and included assets of the INTERNATIONAL MEI HUA ASSOCIATION, and WORLD TAOISM ASSOCIATION, a total of 105 items valued in excess of Ten Trillion United States Dollars.

These assets of the P.R.O. 14646 asset pool is comprised of Security Bonds, various International Currencies (British Pounds, US Dollars and Deutsche Marks, etc) and Certificates of Deposits (CDs), placed in financial institutions throughout the world for a term period of sixty (60) years. These assets are protected by the guarantees of the international community under laws then in place, and insurance policies which protect these assets for a term period up to one hundred (100) years.

In the interest of long term security and as a protection against possible misappropriation of the asset pool the late **Dr. Sun Yat Sen** willed these assets to be Citizen's Wealth and prior to his death, created a committee of appointed persons charged with managing and protecting these funds and the assets from abuse.

It was late **Dr. Sun Yat Sen's** wish that these funds and assets to be used for nation building and to guarantee the welfare of the future citizens. Therefore, NO individual, political party nor any nation may have a claim or access to the use of these funds and assets for any other purpose.

We have now reached the time when these deposited assets have matured.

Unfortunately, because of the "TWO-CHINA" that have arisen and because of this "TWO-CHINA" division has not been resolved, the funds and assets cannot be applied in the manner intended.



Therefore, the Supreme Council of P.R.O. 14646 has decreed that these funds and assets be applied to assist other nations in their development and in the interest of international peace and global development.

A portion of the asset pool is accordingly being reactivated to meet purpose of the MEI MA JIN FEI (Security Code Term for Personnel Expenses) and for investments into the economy of our host countries where we intend to deposit such funds as they mature.

For the purpose of Human Prosperity of the 21st Century, we established S.A.V.E. GLOBAL HUMANITARIAN DEVELOPMENT FOUNDATION/FUND to promote the New Era International Financial System to found up the coming "Mankind Global Village" accepting Retainers in Global Historical Assets and private (out of or off balance sheet) capitals from Natural Individuals or Entities for Filing, Application and Approval of Human Welfare Development Projects.

In a joint effort and co-operation with YCT DEVELOPMENT CORPORATION said Authorities established S.A.V.E. GLOBAL HUMANITARIAN DEVELOPMENT FOUNDATION/FUND and P.R.O 14646 GLOBAL FOUNDATION/FUND as "Operative Platform" to regenerate those historical assets into a "NEW 21 CENTURY INVESTMENT FUND" in the spirit of "Proposed / Initiated by Citizens", "Executed by Citizens" and for "Benefit to the Citizens" to realize the principles and objects of S.A.V.E. GLOBAL HUMANITARIAN DEVELOPMENT FOUNDATION/FUND and P.R.O. 14646 GLOBAL FOUNDATION/FUND
