



## **INSTRUCTIONS FOR INDIVIDUALS OR ENTITIES POSSESSING THE RELATED ASSETS (FUNDS) / ANTIQUES**

### **SUBJECT:**

The individual or entity(ies) possessing the related assets (funds) / antiques shall hand over their objects to P.R.O. 14646 Headquarters (the Asset Provider) and YCT (the Operator). Both parties hereto make the united efforts to their rights and obligations and the operating procedures of S.A.V.E. Humanitarian Development as below:-

### **PRESUPPOSITION:**

To show one's firm standpoint = Orientation

To assert one's aspiration = to decide on a verdict

To reach mutual understanding = to decide on a project

### **1 - The Applicant for the assets (including objects and bills) shall first of all provide the following documents as undertaking basis:-**

1-1 The Applicant or his legal authorized person shall submit his Letter of Intent with his I.D. Certificate and passport colour copy.

1-2 The Applicant shall submit his relevant documents and the photos as evidence of the origin of the assets.

1-3 The Applicant shall give Power of Attorney to appoint Mr. Eric HOAK as the Asset Provider for this transaction to process the related banking formalities and the delivery of said assets.

1-4 The Applicant may submit the Humanitarian Development Projects for further feasibility studies.

### **2 - The Applicant in possession of funds or electronic ledger shall first of all submit the following documents as undertaking basis:-**

2-1 The holder of funds (or electronic ledgers) shall submit a Letter of Intent for cooperation.

2-2 The Bank Statement for the Deposit Balance or the Deposit Receipt (Photo Copy).

2-3 Letter of Guarantee (Original).

2-4 Letter of Authority for conducting authentication.

2-5 The Applicant shall give a Power of Attorney to appoint Mr. Eric HOAK as the Asset Provider/Executive for the transaction in order to process the related banking formalities until the respective transaction is completed.

2-6 The holder of funds or his authorized person shall submit his Identification certificate ( ID-Card) and Passport colour copy.

Remarks: If the holder of funds is a legal entity, the Minutes of the Board of Directors resolution and a Power of Attorney for the representative's appointment is required.

2-7 The Applicant may submit the Humanitarian Development Project/s for further feasibility studies.

2-8 The Applicant may choose to establish the regional S.A.V.E. Humanitarian Development Foundation/Fund e.V. or its preparatory office. The S.A.V.E. (Global) Humanitarian Development Foundation/Fund e.V. will examine and approve the project proposal and utilize the investment funds on a Build, Operated, Owned (B.O.O.) Basis.



**3 - The Holder of Funds shall negotiate with his bank/s to confirm the operating pattern as below:-**

3-1 The Operator shall arrange the Guarantor to pay the processing fees of said Transaction as required by the Depositing Bank.

3-2 The Guarantor shall guarantee the payment to respective beneficiaries.

**4 - The Antique's Applicant shall first of all provide the following documents and relevant photos as undertaking basis:-**

4-1 The Applicant shall submit a Letter of Intent for Cooperation.

4-2 The Applicant shall offer the related documents/photos and Detail Inventory List as evidence of the origins of the antiques.

4-3 The Applicant shall give a Power of Attorney to appoint Mr. Eric HOAK as the Asset Provider/Executive to process the related banking/financial formalities and deliver the antiques.

4-4 The Applicant may submit the Humanitarian Development Project/s for further feasibility studies.

4-5 The Applicant may choose to establish the regional S.A.V.E. Humanitarian Development Fund e.V. or its preparatory office. The S.A.V.E. Global Humanitarian Development Foundation/Fund e.V. will examine and approve the project proposal and utilize the investment funds on a Build, Operated, Owned (B.O.O.) Basis.

**5 - Conclusion:-**

5-1 Both parties sharing the same aspiration and sincere intention to reach the cooperation for the funds to be used for project(s) of S.A.V.E. Humanitarian Development as the basis for the Operator to undertake the Transaction.

5-2 The Operator will authenticate and verify the above funds and will respond by an official letter or will sign the agreement.
