This Bank has been founded and funded in 2002 / 2003 by the Founder Committee of P.R.O. 14646 HEADQUARTERS / S.A.V.E. / YCT and is actually applying for the appropriate international licences to execute its designated operations. It is a non-public bank serving specific technical and international purposes.

b) A State or National S.A.V.E. Humanitarian Development Foundation/ Fund is formed by and consists of three parties:

1.) President / Prime Minister of the country and his/its ministers

2.) YCT Development Corporation

3.) International Financial Committee Members

The State or National S.A.V.E. Humanitarian Development Foundation / Fund has an International Vocation after having been established and registered the respective NGO-Section of the UN-Organization.



After completion of the set up of a S.A.V.E. Humanitarian Development Foundation/Fund in a country a contact person, if necessary, will be arranged with the following International Agencies for registration and/or filing along with respective Codes and Numbers:
